## Urban Greening in the Global South: Green Gentrification and Beyond

This comprehensive and up-to-date reference work and resource book covers state-of-the-art and state-of-the-practice for bridge engineering worldwide. ## Handbook of International Bridge Engineering

This book pragmatically explores the myths, concepts, policies, key conditions and tools for enhancing creative knowledge cities. The authors provide a critical reflection on the reality of city concepts including university-city alignment for campus planning, labour market conditions, social capital and proximity, triple helix based transformation, and learning by city governments. # **Creative Knowledge Cities**

In Urban Warfare, Rolnik charts how the financialisation of housing has become a global crisis, as models of home ownership, originating in the US and UK, are being exported around the world. These developments were largely organised by htosw who benefit the most: construction companies and banks, supported by government-facilitated schemes, such as 'the right to buy', subsidies, and micro-financing. Using examples ranging from Kazakhstan, Indonesia, Chile, Israel, Haiti, the UK and especially Brazil, Rolnik shows how our homes and neighbourhoods have effectively become the \"last subprime frontiers of capitalism\". This neoliberal colonialism is experienced on the scale of the city but also within our everyday lives. Yet since the financial crisis and wider urban politics that have left millions homeless, forced from their homes because of urban development politics, and mega-events such as the Rio World Cup in 2013. These narratives are weaved together with theoretical reflections and empirical evidence to explain the crisis in depth. In response, Rolnik restates the political need for activism and resistance. Examining in detail the June Days protests in Rio, 2013-14, she shows that housing remains an essential, and global, struggle.

#### **Brazil**

The purpose of the book is to assess the process of urban verticalization in different contexts through time, to provide insight into the relationships between highrise design and the way inhabitants negotiate them in their everyday lives, to assess how planners, politicians, and designers negotiate residential highrises in the strategies they develop for building the city and to introduce urban narratives and cartographies. Verticalization, although not new, currently takes place in a very different context than post-1945. Today, highrise residential buildings are more than architectural solutions: they are commodities in a global market where capital flows are fixed by developers and municipalities. Our exploration of residential verticalization is anchored in case studies, revealing different types of local-global negotiations in the design of the city, and has been framed by three interrelated dynamics: first, the complex relationships within the financialization of real estate markets, revealing differences in the types of local-global negotiations in the construction of the neo-liberal city; secondly, the most developed, anchors residential verticalization in the processes of sociospatial differentiation within cities (mostly identified as gentrification associated to processes of urban renewal and densification; the third, related to readings and interpretations of the urban landscape and social, spatial practices and its iconographic and cartographic representations. This book is of interest to academics, students, planners, architects, and urban studies professionals. It shows that the chosen research object is an increasingly relevant angle of analysis of the contemporary city. It also provides a better knowledge of the processes of residential verticalization, their impact on the privatization of the urban space, and on urban segregation or fragmentation.

# **Cartographies of Place**

This book analyses the struggle for social justice in São Paulo, Brazil. It takes the wave of protests that began in the city in 2013 as a starting point, and grounds them in the history of social movement mobilisation in urban Brazil. Drawing on ethnographic fieldwork with a federation of housing movements, this work demonstrates the ongoing relevance of the concept of the right to the city for social movements of the urban poor, and examines these movements' creative interpretation of national legislation to support their claims for housing and urban citizenship.

# Transgressive Citizenship and the Struggle for Social Justice

This book analyzes in detail the main social, economic and special transformation of the city of São Paulo. In the last 30 years, São Paulo has become a more heterogeneous and less unequal city. Contrary to some expectations, the recent economic transformations did not produce social polarization, and the localized processes of spaces production (and the plural is increasingly important) are more and more key to define their respective growth patterns, social conditions, forms of housing production, service availability and urban precariousness. In other dimensions, however, inequalities remain present and strong and certain disadvantaged areas have changed little and are still marked by strong social inequalities. The metropolis remains heavily segregated in terms of race and class, in a clear hierarchical structure. The book shows that it

is necessary to escape from dual and polarity interpretations. This did not lead to the complete disappearance of a crudely radial and concentric structure (not only due to geographic path dependence), but superposes other elements over it, leading to more complexes and continuous patterns. A general summary of these elements could perhaps be stated as pointing to greater social/spatial heterogeneity, accompanied by smaller, but reconfigured inequalities.
